<u>DISTINGUISHING FEATURES OF THE CLASS</u>: An employee in this class is responsible for supervisory activities of the Sheriff's Office, exclusive of the County Corrections Division, on an assigned shift. Supervision is exercised over Deputy Sheriff's and Dispatchers through inspection and the assignment of duties in accordance with general instructions received from a superior officer. The work is performed under general supervision of the Sheriff or a higher ranking officer. Does related work as required.

## **TYPICAL WORK ACTIVITIES**: (Illustrative Only)

- Has immediate supervision of the activities of all Deputy Sheriff's and Dispatchers on an assigned shift;
- Checks Deputy Sheriff's and Dispatchers in the performance of their duties and suggests methods for better execution of work;
- Briefs and Inspects Deputy Sheriff's prior to their commencing duties for compliance with departmental regulations;
- Assists in handling difficult or unusual law enforcement situations;
- Personally takes charge at scene of serious or unusual accidents;
- Reports any breach of duties or inefficiency;
- Directs and performs criminal investigations when assigned;
- Classifying and safeguarding criminal identification material in accordance with standard scientific principles and methods;
- Receives and reviews daily reports submitted by Deputies;
- Prepares shift activity reports, traffic reports, office reports and ticket issuance reports;
- Performs typical road patrol law enforcement activities;
- Performs a variety of special assignments as directed by a superior officer.

## FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES & PERSONAL CHARACTERISTICS MINIMUM QUALIFICATIONS:

Good knowledge of modern principles and practices of law enforcement work; good knowledge of the New York State Penal Law, Code of Criminal Procedure, Vehicle and Traffic Law and all local laws, ordinances and regulations pertaining to the Sheriff's Office; good knowledge of the geography of the locality; ability to instruct and direct subordinates; skill in the use of firearms; familiarity with the operation of radio equipment; ability to deal effectively and secure the cooperation of subordinates and the public; keen observation; mental alertness; tact; courtesy; good judgement; physical condition commensurate with demands of the position.

MINIMUM QUALIFICATIONS – PROMOTIONAL: At time of examination, must be employed on a permanent basis in the competitive class within the Tioga County Sheriff's Office and have permanent status with continuous service for thirty-six (36) months immediately preceding as either Deputy Sheriff or Police Officer, twenty-four (24) months of which must have been as a member of the Tioga County Sheriff's Office.

**Special Requirement**: Incumbents must take and pass the MPTC Supervisory Training within one year of being appointed, if not previously completed. Failure to complete this training within one (1) year will be deemed as vacating this position.

## **Special Notes::**

- 1. Tioga County Civil Service Rule XIV, Section 9, states, "Police Officer and Deputy Sheriff Appointments. Hereinafter the term Police Officer shall include Deputy Sheriff."
- 2. Requirements—New York State Civil Service Law Section 58-1-b. (effective Sept. 1, 1984) Notwithstanding the provisions of any other section of law, general, special or local, in political subdivisions maintaining a police department serving a population of one hundred fifty thousand or less, no person shall be eligible for appointment nor shall he or she be appointed to any rank above the rank of police officer unless he or she has been appointed a police officer from an eligible list established according to merit and fitness as provided by section six of article five of the constitution of the state of New York or has previously served as a member of the New York State Police.
