The purpose of this Request for Proposal (RFP) is to solicit proposals from various engineering firms to provide the following deliverables on a culvert design on Fox rd. in Apalachin NY. Tioga County SWCD will require:

- an Engineering Assessment that conforms to state requirements of Title 6 of NY Rules and Regulations, Part 673.13, NRCS National Operation & Maintenance Manual Formal Inspection and, and American Association of State Highway and Transportation Officials Load Resistance Factor Design (LRFD) Bridge Design Specifications, with interim revisions, and the NYSDOT Highway Design Manual
- 2) A 100% engineered design fully considering up and downstream impacts including all necessary field surveys, hydrology and hydraulics analysis, a full materials specifications for the culvert replacement design, headwalls, wing walls and all appurtenances associated with the design for the culvert replacement, including any instream structures, bank protection, natural installations to protect the culvert, stream approach and aquatic organism passability.
